Effective access to the website is nevertheless to be granted in accordance with the timeline and provisions laid down in Annex II, point B 1.1 (4) of Regulation (EU) 2023/1670, for smartphones, and in Annex II, point D 1.1 (4) of Regulation (EU) 2023/1670, for slate tablets.
- (g) The supplier shall not enter these data for each model if automatically provided by the database.
